Overview

Fisheries New Zealand is proposing changes to improve our fisheries management system. The proposals are:

- Amending the rules for commercial fishers that set out what fish must be brought back to port and what fish can be returned to the sea.
- Reviewing the offences and penalties regime.
- Streamlining the decision-making process for setting catch limits.
- Technical fisheries management changes.

The following questions are designed to stimulate your thinking and help us report back clearly on people's feedback. There are spaces after each question to provide your response.

Your feedback will inform the next steps in this process, which includes developing and seeking approval for policy changes and any necessary legislative changes.

Once the policy settings have been considered by the Minister of Fisheries and agreed in 2019, the next step will be to consider appropriate options to improve our monitoring and verification capabilities for commercial fisheries.
