Since the 1970s the New Zealand Sport Fishing Council (NZSFC) has actively advocated for recreational fishing interests in the South Island. In 1975 the Fiordland Game Fishing Club became the first incorporated organisation in the south to affiliate to the Council. Prior to their affiliation, the NZSFC had successfully advocated issues of interest to recreational fishers nationally.

In 2012 the NZSFC established LegaSea to raise public awareness about the issues affecting our marine environment, what's at stake both regionally and nationally. With the support of the NZSFC, LegaSea is now collaborating with a wide range of fishing, environmental, and public interest representatives and organisations.

LegaSea is also inspiring people to contribute financially to help spread the load of resourcing our advocacy effort. Since its inception, LegaSea has operated a 100% Commitment Policy whereby all public donations and unaffiliated club contributions are distributed to the NZSFC to be administered by the Fisheries Management Standing Committee to spend on Advocacy, Research, Education and Alignment. These four work streams feed into the NZSFC submissions.

This record is a preliminary summary of NZSFC submissions made from 2009 onwards, in response to processes of relevance to the South Island including some national issues. These include responses to fisheries management and policy proposals, fisheries and spatial plans, aquaculture, and Māori customary management proposals. It is preliminary because the online records are incomplete and some details have been lost over time, including much of the pre-2009 records. However, this is a living document meaning it will be updated with new details in the future.

This chronological summary of submissions excludes the many attendances at meetings, Working Group, research and management discussions, and engagement in other processes. Those engagements are reported comprehensively and separately.
